We have performed the procedures enumerated below, which were agreed to by Stone Ridge Owners Association Inc., solely to assist you with the respect to the accounting records of Stone Ridge Owners Association Inc. as of December 31, 2022. This agreed-upon procedures engagement was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

#### Our procedures performed and findings are as follows:

#### Agreed-upon procedure:

 We reviewed bank statements and summarized all of the deposits received for each of the following years: 2020, 2021, and 2022. We compared these totals to those reported in the summarized financial information from Stone Ridge Owners Association Inc. to ensure revenue was being recorded accurately.

Findings: No material differences were noted.

#### Agreed-upon procedure:

2. We traced a selection of invoices provided by the Association to the bank statements to ensure that expenses were being recorded correctly. For the years 2020 and 2021, we selected on month per quarter and traced all invoices to the monthly bank statements. For the year 2022, we traced all invoices for the year to the monthly bank statements. In addition, for the year 2022, we traced all of the expenses to the summarized financial information.

Findings: Overall, expenses appear to be fairly stated and recorded accurately.

Exception 1: No support was provided for 2021 check number 472 for \$2,850.

Exception 2: For 2022 expenses, we found a total of \$1.00 in expense present on the bank statements that were not recorded in the summarized financial information.

We were not engaged to, and did not conduct an audit, the objective of which would be the expression of an opinion on the accounting records. Accordingly, we do not express such an opinion. Had we performed additional procedures, other matters might have come to our attention that would have been reported to you.
